- Special needs of students, Faculty and Staff with disabilities are given due care in the event of an emergency.

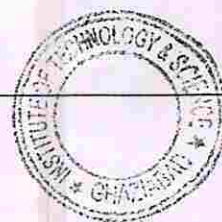



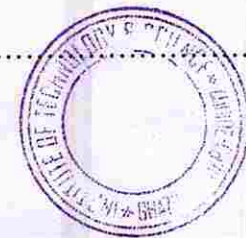

### **'Parivartan' – The Slum Education Programme** **Activity on 10th March, 2019**

#### **A Report**

The sun's rays are getting warmer, the caress of the light on faces is no longer comfortably warm, but the fervour to learn refuses to die down. Today was a day for rejoicing **International Women's Day**, and appropriately enough, to focus on the shameful practice of Sati.

The volunteers for the day were Jhalak Agarwal, Megha Kandpal, Shruti Mishra, Samina, Nargis, Abhishek Dwivedi, Anand Kumar Jha, Rahul Raj, Chetan Kumar Gupta and Robin Sharma.

First it was Nargis, a regular presence at the Sunday sessions, who reminded the kids about the importance of observing a day for women. She admirably traced out the history of the movement towards the emancipation of the fairer sex, including the securing of voting rights. She explained to children the meaning of equality of the sexes, and why it was necessary for females to get their due respect and position in society, including equal pay for equal work.

The other debutant teacher of the day was Anand, who took care of the second session on the practice of sati and its abolition. He began like an expert, providing mythological and historical context to the subject, referring to sati committed by Goddess Durga when her father objected to her choice of Shivji as a husband, and also the first known historical instance of Sati in Rajasthan. In order to aid the understanding of the learners, Jhalak quoted the examples like that of "jauhar" committed by "Queen Padmavati" and ladies of her court when her husband was defeated in battle by the invading Alauddin Khilji. Anand also highlighted the role of social reformer Raja Rammohan Roy and Lord William Bentinck in this regard.

After the usual quiz on the day's interactions, a prize distribution ceremony was conducted using soft toys graciously gifted by members of ITS Parivar. This brought the day to an end with the

distribution of 'Crax Rings' and 'Good Day' biscuits among the children. Executive member Samina Khatoon was present as she had come to distribute chocolates among the children.

Dr. Indraneel Mandal accompanied and motivated the student volunteers. Prof. Lokesh Upreti planned and guided the volunteers in the conduct of the programme as the faculty coordinator of CSR Club - Parivartan.

## Guest Lecture on PREVENTION AND EARLY DETECTION OF CANCER on August 27<sup>th</sup>, 2019

The objective of guest lecture was to know about cancer disease, Types of cancer, Treatment of cancer, Palliative care for cancer, Need for palliative care and benefits of palliative care.

Cancer, also called malignancy, is an abnormal growth of cells. There are more than 100 types of cancer, including breast cancer, skin cancer, lung cancer, colon cancer, prostate cancer, and lymphoma. Symptoms vary depending on the type. Cancer treatment may include chemotherapy, radiation, and/or surgery. Most cancers form tumors, but not all tumors are cancerous. There are many types of cancer treatment. The types of treatment that you have will depend on the type of cancer you have and how advanced it is. Some people with cancer will have only one treatment. But most people have a combination of treatments. Cancer gives most people no symptoms or signs that exclusively indicate the disease. Unfortunately, every complaint or symptom of cancer can be explained by a harmless condition as well. Some cancers occur more frequently in certain age groups. Palliative care is care given to improve the quality of life of patients who have a serious or life-threatening disease, such as cancer. Palliative care is an approach to care that addresses the person as a whole, not just their disease. The goal is to prevent or treat, as early as possible, the symptoms and side effects of the disease and its treatment, in addition to any related psychological, social, and spiritual problems. Palliative care is also called comfort care, supportive care, and symptom management. Patients may receive palliative care in the hospital, an outpatient clinic, a long-term care facility, or at home under the direction of a physician. The lecture was very informative.

- The Grievance Cell will assure that the grievance has been properly solved in a stipulated time limit provided by the cell.
- In case of any false/frivolous Complaint, the Staff in-charge may order appropriate action against Complaint.

#### **FUNCTIONS:-**

The cases are attended promptly on receipt of written grievances from the students. The cell is indented to find solutions for problems like sexual harassment –any kind of physical or mental harassment, complaints regarding class room, completion of syllabus, Teaching methods etc, when arise. The Grievance Redressal Cell convenes meetings periodically, record the minutes and takes steps to redress the grievance.

**Establishment of a Grievance Redressal Committee:-** The Grievance Redressal Cell of the institute having provision Director as the Chairman and Faculty as members. The cell is having the provision of being reconstituted every year if situation arises. The cell meets twice in solve the grievances raised by the students.
