This has reference to your application dated 09.12.2014 seeking accreditation by National Board of Accreditation to Masters in Computer Applications (MCA) programme offered by Institute of Technology and Science, Mohan Nagar, Ghaziabad, Uttar Pradesh.

2. An Expert Team conducted on-site evaluation of the programme during 22nd to 24th July, 2016. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. The competent authority in NBA has approved the following accreditation status to the programmes as given in the table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The program(s) have been granted provisional accreditation. Institute of Technology and Science, Mohan Nagar, Ghaziabad, Uttar Pradesh should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above.

5. The accreditation status awarded to the programmes as indicated in the above table does not imply that the accreditation has been granted to Institute of Technology and Science, Mohan Nagar, Ghaziabad, Uttar Pradesh as a whole. **As such, the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is programme accreditation and not Institution accreditation.
